1. Since, the issue involved in all these writ petitions is common, hence, with consent of learned counsel for both parties, this batch of writ petitions has been heard finally on merits and would stand decided by this common order.
2. Petitioners, by means of filing instant writ petitions, have raised a common grievance for not granting the selection scale for the post of Sub-Inspector (SI) on completion of 18 years of service from the post of Constable (Driver). It has been pointed out that petitioners belong to M.T. Cadre and since promotional post of ASI from Head Constable is not available, petitioners are eligible and entitled to get selection scale on the next promotional post i.e. Sub-Inspector.
3. Counsels for the petitioners submit that the issue raised by petitioners in the instant writ petitions, has been answered positively by the Coordinate Bench at Principal Seat, Jodhpur vide Judgment dated 20.12.2023 passed in **S.B. Civil Writ Petition No.3873/2019 titled Amar Singh & Ors. Vs. State of Rajasthan & Ors.**, placing reliance on the judgment rendered by Division Bench in **D.B. Special Appeal (Writ) No.763/2011 decided on 02.08.2011 titled State of Rajasthan & Ors. Vs. Banney Khan**, and affirmed by the Hon'ble Apex Court in *Civil Appeal No.1766/2015* on 12.05.2015. The relevant paras of the Judgment of Coordinate Bench dated 20.12.2023 reads as under:-

"10. This Court further observes that the judgment rendered by a Division Bench of this Hon'ble Court in the case of State of Rajasthan & Ors. V/s Banney Khan (D.B. Civil Special Appeal (W) No. 763/2011) was challenged

before the Hon'ble Apex Court in Civil Appeal No.1766/2015 and the same was affirmed by the Hon'ble Apex Court on 12.05.2015.

11. This Court also observes that the petitioners were appointed on the post in question as M.T. Cadre and thereafter, their next promotional post was Head Constable and then Sub-Inspector as per the M.T. Cadre, and therefore it is clear that the petitioners are eligible for pay scale of the next promotional post, but the said benefit was denied by the respondents, which is not justified in law.

12. This Court further observes that the petitioners at the completion of 9 years of regular services, were granted the pay scale of the next promotional post, but thereafter, on completion of 18 years of the services, the respondents did not grant them the benefits of the next promotional post, which impugned action is not sustainable in the eye of law, because the respondents at the first instance i.e. completion of 9 years of services considered the petitioners for next promotional pay scale as per the M.T. Cadre, but at the same time, denied them the same benefit on completion of 18 years of service.

13. This Court also observes that the impugned action of denial of grant of the pay scale of the next promotional post to the petitioners by the respondents and granting the petitioners the pay scale of different Cadre i.e. Assistant Sub-inspector is not permissible in the eye of the law.

14. Thus, in light of the above observations and afore-quoted precedent laws as well as looking into the factual matrix of the present case, the present petition is allowed and the impugned order dated 10.12.2018 is quashed and set-aside, while directing the respondents to grant to the petitioners the pay scale benefits of the next promotional post as per the M.T. Cadre i.e Sub-Inspector from the date the petitioners became eligible therefor. All pending applications stand disposed of."

4. Counsel for respondents, appearing for and on behalf of the State, does not dispute that the issue raised by petitioners in the present writ petitions is covered by the final judgment dated 20.12.2023 passed in *Amar Singh (supra)*.

5. Learned counsels for both the parties admit that the judgment passed in case of *Amar Singh (supra)* has been implemented, as the State Government did not opt to assail the judgment passed in case of *Amar Singh (supra)* dated 20.12.2023.

6. In view of above, all the instant writ petitions are allowed in terms of judgment dated 20.12.2023 passed in case of *Amar Singh (Supra)* and petitioners are also entitled to get benefit of selection scale for the post of Sub-Inspector, on completion of their 18 years of service on the post of Constable (Driver).

7. Stay applications and other pending applications(s), if any, also stand disposed of.
