1. Instant third bail application has been filed by petitioner under Section 483 of BNSS, 2023 in connection with FIR No.184/2025 registered at Police Station Nihalganj, District Dholpur for offences under Sections 319(2), 318(4) & 61(2) of BNS and Sections 3 & 10 of Rajasthan Public Examination (Measures for Prevention of Unfair Means in Recruitment) Act, 2022.
2. Heard counsel for petitioner as well as learned Public Prosecutor and perused the material available on record.
3. Taking into consideration the facts that this third bail application has been filed, after submission of charge-sheet against petitioner, and allegation against the petitioner is that he

appeared in place of a student in the Pre- D.E.L.AD Examination- 2025, which is not a public examination, hence, charge-sheet against the petitioner has been filed for offences under Sections 319(2), 318(4) & 61(2) of BNS and Sections 3/ 6 of the Rajasthan Public Examination (Measures for Prevention of Unfair Means in Recruitment) Act, 1992, which are triable by the Magistrate; Petitioner is in custody since 02.06.2025 and there are no criminal antecedents of petitioner, but without commenting on merits of the case, this Court deems it just and proper to release the petitioner on bail.

4. Accordingly, this third bail application is allowed and it is ordered that the accused-petitioner **Mohit Sharma S/o Ramnaresh Sharma** shall be released on bail provided he furnishes a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for his appearance before the court concerned on all the dates of hearing as and when called upon to do so, on following conditions:-

- (i) that the petitioner shall not repeat the similar nature of offence during bail granted by this Court and shall cooperate in the trial.
- (ii) that the petitioner shall not tamper with and influence any of the prosecution witnesses;
- (iii) that if the petitioner commits breach of any of the conditions, the respondents shall be free to move application for bail cancellation of accused-petitioner.
